He also received his Master of Public Health (MPH) from the University of Minnesota before returning to Japan and working for McKinsey & Company. He has served government agencies, pharmaceutical companies, and medical device manufacturers, providing analysis, business and marketing strategy support, and internal transformation support. He also serves as the Japanese co-leader of the McKinsey Health Institute (MHI), a non-profit organization that he provides leadership to achieve the organization's goal of extending life expectancy and improving quality of life in all regions, industries, and communities.
